- **“Public official”** shall mean:⁵
 - (i) *any person holding a legislative, executive, administrative or judicial office of a State Party, whether appointed or elected, whether permanent or temporary, whether paid or unpaid, irrespective of that person's seniority;*
 - (ii) *any other person who performs a public function, including for a public agency or public enterprise, or provides a public service, as defined in the domestic law of the State Party and as applied in the pertinent area of law of that State Party;*
 - (iii) *any other person defined as a “public official” in the domestic law of a State Party. However, for the purpose of some specific measures contained in chapter II of this Convention, “public official” may mean any person who performs a public function or provides a public service as defined in the domestic law of the State Party and as applied in the pertinent area of law of that State Party;*
- **“Property”**⁶ shall mean *assets of every kind, whether corporeal or incorporeal, movable or immovable, tangible or intangible, and legal documents or instruments evidencing title to or interest in such assets;*
- **“Proceeds of crime”**⁷ shall mean *any property derived from or obtained, directly or indirectly, through the commission of an offence;*
- **“Freezing”** or **“seizure”**⁸ shall mean *temporarily prohibiting the transfer, conversion, disposition or movement of property or temporarily assuming custody or control of property on the basis of an order issued by a court or other competent authority;*
- **“Confiscation”**⁹, which includes forfeiture where applicable, shall mean *the permanent deprivation of property by order of a court or other competent authority;*
- **“Predicate offence”**¹⁰ shall mean *any offence as a result of which proceeds have been generated that may become the subject of an offence as defined in article 23 of this Convention;*

People's Republic of China (“**The NSL**”) and *Article 23 Legislation* (2024) passed by Hong Kong as domestic security law (Safeguarding National Security Ordinance) in 2024, adding offenses like sedition, espionage, and theft of state secrets, supplementing the 2020 NSL

The Espionage I refer to that is relevant to the Australian Espionage Agencies and the operation of the NSL and the Safeguarding National Security Ordinance is that experienced by me at least since 18th May 2016 relating to my relocation to Hong Kong and most likely as early as the 23rd December 1992 when Suntory offered to acquire the assets of the Andrew Garrett Family Irrevocable Living Trust trading as Andrew Garrett Wines (“The Trust”) for AUD\$1 and threatened to withdraw the Guarantees provided to Mitsui and Sanwa Banks as funding for the Andrew Garrett Group Pty Ltd as Corporate Trustee of the Trust under contract by consulting agreement that was executed on 29th May 1990 concurrent with entering a Shareholders agreement with me settled by Phillips Fox Lawyers concealing Terrorism Financing and Money Laundering activities of Price Waterhouse Coopers since 1987. ¹¹

Equities are Not Abolished; as a matter arising under the operation of the Common Law where there is a discrepancy between operation of law and operation of equity; Equity will prevail.

Australia suspended the operation of the Mutual Assistance and Extradition Agreements executed between Australia and Hong Kong in October 2020 citing concerns over the NSL, the failure of the Australian Government to regulate the Legal Profession is at the heart of my findings of facts, the NSL, the Safeguarding National Security Ordinance and my appointment as Liquidator to the Crown in the 14th August 2020 ¹²..... for enforcement in “the Main Proceedings” within the meaning of *the Cross Border Insolvency Act 2008* (AU) in the Court of the First Instance of Honourable High Court of Hong Kong.

Australia’s “concerns” were akin to “the Pot calling the Kettle Black” and were in reality a smokescreen for the complete collapse of Rule of Law in Australia with rampant Terrorist Activity and Money Laundering perpetrated by the Gatekeeper professions, Executive Branch of Australian Government, Australian Bank Licensees and the Anarchy and Chaos that has continued to prevail in Australia ¹³ notified to the Australian Parliament by me since the International Conventions on the issue of Impunity that led to *the Rome Statute 1998* (UN) and *the International Convention on the Suppression of Terrorism Financing 1999* (UN).

With an annual budget of €380,000,000.00 (Three Hundred Eighty Million Euros) the International Criminal Court has been an abject failure in the fight against impunity with only 7 convictions in the 23 years since commencement of operations necessitated the establishment of the International Crown Criminal Court for the Abolition of Impunity and the International Crown Court of Justice as access to Justice and funding of the Right to an Effective Remedy by the Trustees of the Better World Future Fund.

I refer to my Notice of Protest of Dishonour ¹⁶, Notice of Crystallisation of Personal Property Security Interests issued to Citibank N.A. ¹⁷, Addendum ¹⁸ and my supplementary Letters dated 7th, 11th, 12th and 15th November 2025 as being the relevant Australian law applicable to your conductwhich Offence Findings of Fact remain undisputed by you.

I have previously served upon you in NSD-741-2023 evidence of the clean clear non-criminal origins of value under the enforceable contractual obligations of the Crown to the Trustees of the Andrew Garrett Family Irrevocable Living Trust trading as OenoViva Capital Resources to an effective Remedy under Article 2 of resolution 2200A (XXI) of 16 December 1966 of the United Nations General Assembly, known as International Covenant on Civil and Political Rights.¹⁹

Article 2

1. *Each State Party to the present Covenant undertakes to respect and to ensure to all individuals within its territory and subject to its jurisdiction the rights recognized in the present Covenant, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.*
2. *Where not already provided for by existing legislative or other measures, each State Party to the present Covenant undertakes to take the necessary steps, in accordance with its constitutional processes and with the provisions of the present Covenant, to adopt such laws or other measures as may be necessary to give effect to the rights recognized in the present Covenant.*
3. *Each State Party to the present Covenant undertakes:*
 - (a) *To ensure that any person whose rights or freedoms as herein recognized are violated shall have an effective remedy, notwithstanding that the violation has been committed by persons acting in an official capacity;*
 - (b) *To ensure that any person claiming such a remedy shall have his right thereto determined by competent judicial, administrative or legislative authorities, or by any other competent authority provided for by the legal system of the State, and to develop the possibilities of judicial remedy;*
 - (c) *To ensure that the competent authorities shall enforce such remedies when granted.*
